



PUBLIC CONSULTATION IN THE SPECIAL AREAS - GENERAL

The Special Areas Board ("the Board") recognizes meaningful public engagement is a critical part of the municipal decision-making process. The Board is committed to creating opportunities for meaningful public participation in municipal decisions which directly affect ratepayers.

MUNICIPAL GOVERNMENT ACT & SPECIAL AREAS BOARD – BYLAWS VS. MINISTERIAL ORDERS

As Special Areas is a crown agency, Section 7 and 187 of the *Municipal Government Act (MGA)* are not applicable to the Special Areas Board. The general authority to pass bylaws (or equivalent controls) remains under the authority of the Minister of Municipal Affairs as outlined in the *Special Areas Act*.

Special Areas intends to consider amendments to the Special Areas Land Use Order (LUO) MSD:064/24) last reviewed in 2024. The LUO regulates and controls the use and development of land and buildings within the municipality to facility the orderly and economic development of Special Areas 2, 3, and 4. As proposed amendments to the LUO falls under the municipal role of the Special Areas Board; the Board is adhering to the requirements outlined in Section 187 of the *Municipal Government Act* (Passing a Bylaw).

PROPOSED AMENDMENT TO SPECIAL AREAS LAND USE ORDER (LUO)

The Land Use Order (LUO) controls development by categorizing all properties in a municipality into various land use districts. It prescribes how land and buildings can be used in those districts and establishes a system for issuing development permits. The LOU is a tool to help ensure that development aligns with a community's or municipality's overall vision.

Pursuant to the *Municipal Government Act (MGA)*, the Special Areas Board considered a proposed amendment to Land Use Order (MSD: 064/24) (LUO) which introduced definitions, uses and regulations for Battery Energy Storage Systems (BESS) within the Special Areas.

The proposed amendments aimed to regulate future BESS developments, including a planned 10 MW Off-Site Battery Energy Storage System in Special Area No. 2, located southwest of Hanna and southeast of Delia (SW 18-30-16-W4M).

The proposed amendments included:

- Adding definitions for Battery Energy Storage Systems (BESS), distinguishing between Off-Site BESS, On-Site BESS (Small) and On-Site BESS (Large)
- Updating relevant Land Use Districts for BESS developments, including discretionary and permitted uses

- Establishing specific regulations for Off-Site and On-Site BESS, including AUC approval requirements, setbacks, and Emergency Response Plans
- Adding On-Site BESS (Small) to the list of uses not requiring a development permit as required

All BESS projects 1 MW or greater require an application process and approval through the AUC.

PUBLIC CONSULTATION – MARCH 2025

Public consultation related to the proposed amendment to the Special Areas Land Use Order (LUO) began after first reading on February 25, 2025.

Communication activities included advertising for the public hearing scheduled for March 25, 2025, providing information related to the proposed amendment online (www.specialareas.ab.ca) and at local district offices. Detailed activities, as well as copies of communications materials are presented in *Appendix A*. These include:

- Advertisements in local media March 10 & 17, including Oyen Echo, Consort Enterprise,
 Brooks Bulletin, ECA Review, and the Hanna Coffeebreak;
- Advertisement of public hearing online on a weekly basis, posting proposed amendment on Special Areas website;
- Advertisement of public hearing at Special Areas district offices and ensuring information packages were available;
- Circulation of a letter to adjacent landowners of the proposed development informing them
 of the proposed amendments to the LUO and the public hearing.

As a part of this public consultation, individuals were invited to provide written comments through both mail and email (public.input@specialareas.ab.ca). Submissions had to be received by March 20, 2025. This submission deadline was well communicated in advance.

No written submissions were received by the submission deadline.

PUBLIC HEARING - MARCH 25, 2025

A public hearing was held at 1:00 pm on March 25, 2025 in Youngstown, AB. No members of the public attended the public hearing; three representatives from BluEarth attended in addition to Mr. Devin Diano, CEO of Palliser Regional Municipal Services.

The purpose of the proposed amendment to the Land Use Order was reviewed, along with proposed amendments to the LUO. Proposed setbacks were reviewed noting AUC does not set a fixed setback for projects but rather assesses each project on a case-by-case basis focusing on noise (Rule 012), fire and explosion risk, emergency response, and air quality dispersion modeling.

The process used for advertising by the Special Areas was reviewed, and it was confirmed no written submissions were received by the submission deadline.

BluEarth representatives reviewed the proposed BESS project. Questions related to emergency response planning and impacts of potential fire(s) at the site were discussed, as well as noise impacts and setbacks. A copy of the public hearing minutes is presented in *Appendix B*.

SECOND READING

Ahead of second reading, the Board reviewed the proposed amendments to the LUO (related to BESS) with Mr. Devin Diano from Palliser Regional Municipal Services. The Board had requested setbacks be reviewed after the public hearing, including those related to residential dwellings and sound levels.

Two amendments were made ahead of second reading: one which established a 800m minimum setback for Off-Site BESS from existing habitable dwellings, and one which deferred the sound level setbacks to the AUC (Rule 012).

After these amendments had been made, the Board held second reading on the proposed amendment to the Land Use Order. The Board recommended the Minister sign the proposed amendment to the Land Use Order as amended prior to second reading.

SPECIAL AREAS LAND USE ORDER Public Hearing – March 25, 2025

1:00 PM

A public hearing was held in the Main Boardroom at the Youngstown Service Centre Tuesday, March 25, 2025 at 1:00 PM with the following in attendance:
Brad Slorstad, Kevin Wilson and Doug Noble, Board Members; Shaune Kovitch, Chair; Trent Caskey, and Darren Jones, Directors; Taryl Abt, Darran Dick, Brett Richards (via Teams); Administrators; Maeghan Chostner, Communications; and Shyanne Jones, Recording Secretary.

Mr. Devin Diano, CEO of Palliser Regional Municipal Services was also in attendance, along with three representatives from BluEarth.

The Chair called the Public Hearing to order at 1:00 PM and explained the purpose and process of the hearing.

Mr. Diano reviewed the proposed changes to the Special Areas Land Use Order to include Battery Energy Storage Systems (BESS) as a discretionary use within the Agricultural District. There are two types of BESS:

- 1. Off-site BESS primarily designed to supply electricity to the grid for commercial sale.
- 2. On-site BESS intended to support on-site electricity needs but may also feed excess energy into the grid (small scale residential or business use).

The definitions to be added to the SA LUO include:

- 1. Battery Energy Storage Systems (BESS)
- 2. Off-Site BESS Primary off-site use through electrical grid
- 3. On-Site BESS Small (<1MW)
- 4. On-Site BESS Large (≥1MW)

The proposed setbacks were reviewed noting the AUC does not set a fixed setback for projects but rather assesses each project on a case-by-case basis focusing on noise (Rule 012), fire and explosion risk, emergency response, and air quality dispersion modeling.

Special Areas can establish setbacks in the LUO. This would be consistent with other setbacks outlined in the document.

Ms. Chostner reviewed the interim report. The public hearing was advertised as part of the *MGA* requirements and shared on social media channels. The request for written submissions was advertised, but none were received.

Mr. Tyler Kurchina, Ms. Tara Jones, and Mr. Daryl Scheerer from BluEarth were in attendance along with Dr. Stephen Ramsay via Teams and had a presentation.

Mr. Scheerer provided information on the BluEarth history and current operations.

Mr. Kurchina reviewed the proposed project noting it would consist of six battery storage containers with power conversion systems, three medium voltage transformer skids, a switchgear & control building as well as perimeter fence on approximately one acre. The construction workspace would take up approximately three acres.

There is an emergency response plan in place which is a requirement of the AUC application. It was noted the lands

would be restored to the current condition after the 20-year life cycle for the project.

The current project status was reviewed noting AUC provided approval in March 2025, construction is slotted for Q2 of 2026 with an estimated service date of October 2026.

There was a question on fire in the site and how long the batteries would burn. Dr. Ramsay noted there has been significant evolution of battery storage systems to address the issues in earlier systems. The current systems are less susceptible to thermal runaway.

The proposed project has 10MW of capacity and can send to the grid for two hours.

There was a question on disposal. The technology is new for this size of battery and there is investigation into recycling of the batteries.

The batteries are rated to operate from -45 Celsius to plus 40 Celsius, the composition has changed and there's no evidence an explosion can occur, they burn and don't explode.

Noise can be a factor and there was discussion on the setbacks, for wind the setback is 800m from a dwelling and 45dBA from the property line. It was noted the pitch should be considered in addition to the decibel levels. It was noted the noise is cumulative so other projects in the area need to be considered.

Mr. Kovitch thanked the presenters for coming today and providing insightful feedback. The feedback will be taken into consideration prior to second reading.

The Chair closed the Public Hearing at 2:14 pm.
